A DRT enabled EHR takes transcribed output and enters it directly into the patient’s clinical chart as discrete recordable data, meaning the documentation can be queried for statistics, graphing, reporting and contributes to a “Full EHR” system!

Studies reveal that template based charting could distract from important cognitive workflow for providing care, thus limiting thoughtful review and analysis. DRT allows practices to view clinical data without giving up “narrative dictation”.

According to research, the top two reasons that EMR adoption and implementation are no further along are *COST* and *DISRUPTION OF THE PRACTICE*. These two companies have
